WORK EXPERIENCE AND ACTIVITIES

- **Elected by Najaf lawyers** with a voter rate of more than 80% and in the presence of the president, members of the Bar Council, and a number of branch heads in the governorates.
- **The signing of a reconciliation agreement** between the Najaf Police Command and its lawyers, and for the first time in Iraq's history, such an agreement is signed, in which it is emphasized that the lawyer is respected in the province and that have access to the investigative papers following the provisions of the Law of Advocacy. The agreement included several paragraphs after there was a heated dispute with the police leadership in this regard.
- **Organized many conferences and seminars** in the presence of many Iraqi lawyers, especially from the western regions, and also organized a conference to renounce sectarianism in Iraq with the attendance of Iraqi lawyers from all provinces.

- **Distributing 500 cars to lawyers** of various models in coordination with the Iraqi International Motors Company and Al-Rasheed Bank_ AL Kufa branch, in easy bank installments.
- **Organizing several professional and highly disciplined extensions of validity courses** through the teaching staff of judges and professors of well-established lawyers who possess professionalism. These courses were attended by many lawyers from the nearby governorates.
- **Establishing the first residential neighborhood for lawyers in Iraq** (Lawyers District - Najaf Governorate) consists of (274) hectares for the lawyers of the governorate and districts.
- **Allocation of the land of 200 hectares** attached to the Lawyers District in Najaf. It was planned to be distributed for the third and fourth sessions of all AL_Najaf lawyers, but the general administration was dissolved by the Bar Council.
- **Head of the Iraqi delegation of lawyers** to visit Syria and meet with Syrian Prime Minister Wael Al-Halqi.
- **Obtaining 200 academic MA and Ph.D. degrees seats** before dissolving the Najaf Mandate Commission.
- **Preserving the Bar and lawyers and defending their rights** from all decisions identified by the President of the Bar and members of the Bar Council.
- **Founder of the lawyers' echo magazine** to spread legal culture and encourage lawyers to write and attract all competencies.
- **Obtaining the title of the best professional and union personality** in 2014 by union figures and circles.
- **Obtaining many certificates of appreciation and letters of thanks** by practicing the legal profession and participating in many advisory and development courses inside and outside Iraq, due to excellence, professional competence, and impartial integrity.
- **Refusal to belong or be nominated for a bloc or party** that communicates excellence and integrity.
- **Leading the project of professional change** and reform to change the reality of the Bar Association to be nominated for the position of head of the Iraqi Bar Association in 2016 and come close to winning the position and then continue to run in the elections in 2019, but was expelled by an unfair political decision the day before the elections. He resolved to run for the nomination and run in the elections in 2002 with a group of Iraqi lawyers for the position of captain and membership of the Bar Council.
- **Filing a lawsuit in the Federal Supreme Court** in 2016 that the Revolutionary Command Council Resolution No. 180 regarding the nomination of union leaders for more than one electoral cycle was unconstitutional.
- **Contribute to the issuance of Resolution (48)** for the year 2018 regarding the cancellation of Resolution (180) by obtaining a resolution from the House of Representatives and voting on it.
